Re: 8YY / Toll Free Access Charge Reform Intrastate Access Revisions

Dear Mr. Jones:

On behalf of Hayneville Fiber Transport, Inc. d/b/a Camellia Communications, please find the attached tariff revisions to the intrastate access service tariffs. The purpose of this filing is to comply with Federal Communications Commission ("FCC") amended rules which implement 8YY access charge reform. FCC 8YY access charge reform requires all rate-of-return incumbent local exchange carriers ("LECs") to modify all the originating 8YY rates in the following groups: End Office/Local Switching, Transport, and query charge.

Local Switching:

The FCC order requires LECs to transition their interstate and intrastate toll free (or 8YY) originating end office access service rates to bill-and-keep over a three-year period. As part of the transition, beginning July 1, 2021, carriers are required to tariff separate rate elements for toll free and non-toll free interstate and intrastate originating end office access service. In 2021 the intrastate toll free originating end office access service rates must be reduced to interstate levels if intrastate rates exceed comparable interstate rates. Next year these local switching rates will be reduced by 50% and then to zero in year three: 2023.

Transport:

All incumbent LECs are required to tariff rate elements for interstate and intrastate non-toll free originating transport service between an end office and tandem switch and remove these rate elements from their tariffs for toll free originating traffic, and tariff a new single rate element of no more than \$0.001 per minute for joint tandem switched transport access service for toll free calls. The Joint Tandem Switched Transport access service rate element may only be charged if the company has a tandem. No additional adjustments will be made to the transport rate elements in

subsequent years. Although this transport rate element is new, it will not result in an increase in access charges due to the reduction in other rate elements.

Query Charge:

Finally, incumbent LECs are required to reduce the intrastate and interstate toll free database query charges in their tariffs to no more than \$0.004248 per query. Further reductions will be made to the query rate in 2022 and 2023.

SECTION 3 INTRASTATE ACCESS SERVICES

3.5 Rates

A. Hayneville Fiber Transport, Inc. adopts the National Exchange Carrier Association, Inc.'s ("NECA") Interstate Access Charge Tariff F.C.C. No. 5, effective as of April 16, 1996 and any successive issues thereto, as found at https://www.neca.org/Tariff_5_Landing_Page.aspx and approved by the FCC for intrastate use. This Tariff was filed with the FCC by the NECA on behalf of the NECA's member companies. This Tariff, along with S3.5.A.1., includes all the rules, regulations, rates and charges under which intrastate access services will be offered to all telecommunications providers.

Exceptions to this adoption of the tariff schedules are as follows. Unless otherwise stated, these rates, as set forth in paragraph 1 below, apply to originating traffic only:
